After 18 months of lockdowns, mask ups, and remote learning it is great to say Warrior Football is back!

The first priority is to get an up-to-date physical uploaded and complete the parent permission form online before August 9th (link is below). Without an updated physical and a parent permission form, you will not be able to practice. The Illinois High School Association states that a football player must practice 12 days before he is eligible to play in a game.

This season we will continue with the levels we played in the spring. There will be a Varsity/JV team and a Freshmen team. Seniors, juniors, and sophomores will be on the V/JV, incoming freshman will be on the Freshman team. The freshman will play the preliminary game on Friday nights before the varsity game (the expectation is that the Freshman team will stay to watch the Varsity game), and the JV game will be Saturday morning or the following Monday afternoon.
